"THE VIADUCT"


The first edition of the the Viaduct was co-published by the Elkridge Business & Professional Association and the Elkridge Community Association in September 1987. The paper was printed by HoCoMo Freddies Trading Post and was delivered for distribution to the AI Fiberglass. Volunteers delivered them to all residents and businesses in the area. This proved to be an enormous and time consuming task, but was achieved. This method of circulation continued for the first six editions of the paper (through November 1988).

From November 1988 until April 1989 a process of reorganization was taking place. The Community Association assumed the duty of continuing the publication of the Viaduct. During the period of time incorporation papers were filed and Gapp, Inc. was obtained to layout the paper and submit to the printer. The edition was hand distributed as previously. Starting with the June edition every resident in the first election district was to receive a copy via mail. Thus "bridging the gap" was finally achieved, but not without volunteers and the support of the advertisers.



ARTICLES OF INCORPORATION

FIRST: The undersigned Gary Kaufman, whose post office address is 5695 Main Street, Elkridge, Maryland 21227 and Edward J. Huber, Jr., whose Post Office address is 6615 Pheasant Drive, Elkridge, Maryland 21227, being at least eighteen years of age, do hereby form a corporation under the general laws of the State of Maryland.

SECOND: The name of the corporation (which is hereinafter called the Corporation) is THE VIADUCT, LIMITED.

THIRD: The purposes for which the Corporation is formed are as follows: To secure the improvement of, and promote the general civic welfare of, the neighborhood consisting of that portion of the first election district of Howard County commonly referred to as Elkridge, in particular, as well as of Howard County more generally, and to express the views of its members on public matters, including the publication and dissemination of a newspaper, the making of bulk mailings, leafletting and the like, all on a not-for-profit basis.

In general, to carry on any other lawful business whatsoever, in connection with the aforegoing or which is calculated directly or indirectly to promote the interest of the Corporation or to enhance the value of its properties;

The aforegoing enumeration of the purposes, objects and business of the Corporation is made in furtherance, and not in limitation of the powers conferred upon the Corporation by law,

and is not intended, by the mention of any particular purpose, object or business, in any manner to limit or restrict the generality of any other purpose, object or business mentioned or to limit or restrict any of the powers of the Corporation. The Corporation is formed upon the articles, conditions and provisions herein expressed, and subject in all particulars to the limitation relative to Corporations which are contained in the General Law of the State.

FOURTH: The post office address of the principal office of the Corporation in Maryland is 5695 Main Street, Elkridge, Maryland 21227. The name and post office address of the resident agent of the Corporation in Maryland is Gary Kaufman 5695 Main Street, Elkridge, Maryland 21227.

FIFTH: THE CORPORATION SHALL NOT BE AUTHORIZED TO ISSUE CAPITAL STOCK.

SIXTH: The number of directors of the Corporation shall be two which number may be increased or decreased pursuant to the by-laws of the Corporation, and the names of the directors who shall act until the first meeting or until their successors are duly chosen and qualified are: Gary Kaufman, 5695 Main Street, Elkridge, Maryland 21227 and Edward J. Huber, Jr., 6615 Pheasant Drive, Elkridge, Maryland 21227

SEVENTH: The following provisions are hereby adopted for the purposes of defining, limiting and regulating the powers of the Corporation and of the directors and members:

This corporation shall be non sectarian, non partisan and operated on a not for profit basis.
